Notice of Proposed New Regulations and Amendments

In accordance with § 2.1 of the Uniform Administrative Procedures Act, Act No. 38-2017, and Section 3 of the Law of the University of Puerto Rico, Act No. 1 of January 20, 1966, as amended, the Governing Board of the University of Puerto Rico notifies that it intends to approve:

- (1) new Student Regulations of the University of Puerto Rico Bayamón Campus, with the purpose of establishing the rights and duties that correspond to the students of these campuses, in accordance with the Law of the UPR, as well as complementary norms to the General Regulation of Students. The proposed regulations provide for student participation structures, student organizations, electoral processes and student disciplinary rules and processes, among other matters;
- (2) new Student Regulations of the University of Puerto Rico Ponce Campus, with the purpose of establishing the rights and duties that correspond to the students of these campuses, in accordance with the Law of the UPR, as well as complementary norms to the General Regulation of Students. The proposed regulations provide for student participation structures, student organizations, electoral processes and student disciplinary rules and processes, among other matters;
- (3) a new Policy of Open Access to the Results of the Creative Work and Research Produced at the University of Puerto Rico, with the purpose of establishing the norms and mechanisms that regulate the open access of society in general to information, in digital format, of results obtained through research and creative work, carried out by members of the UPR, among other matters; and,
- (4) **Amendments to the University of Puerto Rico General Regulations**, **Article 20.1.8**, with the purpose of requiring UPR's president approval to dean designations prior to its consideration by the Governing Board.

During thirty (30) calendar days from the publication of this notice, all persons interested in submitting comments, or in petitioning for an oral hearing on the proposed actions, must do so in writing, in any of the following ways: (a) sending said comments or request in writing by mail to P.O. All petitions for an oral hearing must include the specific reasons that, in the judgment of the petitioner, make such a hearing necessary.
